Code of Ordinances Sec. 22-22. Exemptions; appeal.

(a) Indigent: Any developed residential premises owned in whole by an individual whose income falls below the federal poverty guidelines for the service year may be exempted from payment of the fee for providing solid waste collection and disposal services, provided the developed residential premises is the individual's primary residence. In order to qualify for the exemption, the individual must submit an application in accordance with Subsection (c)(1) of this Section, including individuals who have previously applied for and received this exemption.

(c) Applications for exemption:

(1) Applications for exemption for indigent persons: Applications for exemptions under paragraph (a) of this Section may be obtained from the Macon-Bibb County Solid Waste Department, or any successor department. The solid waste director or their designee must receive all applications and required documentation for exemptions for the succeeding calendar year by November 1 at 5:00 P.M. No late applications will be accepted. A renewal shall be filed with the Solid Waste Department for each calendar year an indigent person seeks exemption under this Section.

(d)

Approval or denial of application for exemption: The solid waste director, in his/her sole discretion, shall approve or deny the application for exemption. All decisions will be made within fifteen (15) business days of submission of the application.
